1. INTRODUCTION

This activity report aims to summarise the results of the work of the more than one hundred people who currently form part of the Public University of Navarre's Business Administration Department. It would be hard to understand all the different activities, as outlined over the following pages, without the effort and collaboration of all the members of the department, teaching staff, trainees and administration and service staff alike.

The mission of the Business Administration Department has remained unchanged over all these years: to contribute to the development of society through the creation and transfer of knowledge, and the comprehensive education of individuals in the field of Economics and Business Management and Administration.

In the academic year 2015/2016, the members of the department taught in all the Public University of Navarre's different faculties and schools in some 250 modules belonging to thirteen undergraduate degrees, two double undergraduate degree programmes and eleven Master's degrees, and contributed to two PhD programmes. Following completion of the implementation period for the undergraduate degrees adapted to the European Higher Education Area, the challenges now faced involve improving our vertical and horizontal coordination processes, and participation by the department in the development of the Public University of Navarre's new undergraduate degree qualification framework. As for Master's degrees, the challenges consist of consolidating the official postgraduate qualifications available in the field of business management.

The creation and transfer of knowledge has been performed through six research groups and has given rise to participation in various research projects funded through competitive calls, the publication of books, book chapters and articles in academic journals, and papers given at national and international academic conferences. The quality of the vast majority of the department's contributions in this area is reflected by objective indicators, such as the presence of the journals in the leading indexes. In this regard, the challenge lies in continuously improving this research and knowledge transfer work.

Finally, it should be pointed out that the department has not carried out its activities in isolation, but in constant collaboration with teaching staff and researchers from other centres. Professors and trainees in the department have stayed at other universities, both in Spain and abroad, and the department has received staff from other academic institutions.

I hope that this report will prove to be of interest to all those who read it and that it may serve as an invitation to get in touch with us to find out more about everything that the Public University of Navarre's Business Administration Department has to contribute to the development of society.
